Registration & Hotel Information

Registration

Registration is required to attend the Annual Member Meeting (October 19) and/or the GADA-CVM Quarterly Meeting (October 20). GADA Member organizations may register attendees for in-person participation in the Annual Member Meeting, and either in-person or “virtual” participation in the GADA-CVM Quarterly Meeting. There is no registration fee to participate. Members pay their own travel expenses.

To gain access to FDA facilities for the GADA-CVM Quarterly Meeting, on-site attendees will be subject to security screening and will be required to produce a valid photo I.D. upon entering the FDA buildings. **PLEASE NOTE: FDA has a new clearance process for foreign nationals. Meeting attendees who are not a US citizen or do not possess a valid visa will be required to contact CVM to provide additional information prior to attending the meeting and will not be allowed access to the meeting if the required information is not successfully submitted in advance.**

To register: log into the Member Services area at www.gadaonline.org and click on “Register Online!” in the Member Services menu. Be sure to register no later than **Thursday, September 29, 2016.**

Hotel Reservations

Hotel reservations are available at the Courtyard Gaithersburg Washingtonian Center, 204 Boardwalk Place, Gaithersburg, MD 20878, at a special GADA rate of \$165/night plus tax. The room rate includes full breakfast buffet for one guest per room for each night’s stay, and complimentary wireless internet service.

The hotel is located 3.8 miles east of the Shady Grove Metro train station. The Courtyard does not offer shuttle service outside of a 3-mile radius. The Courtyard provides complimentary self-parking for hotel guests in a public parking garage immediately adjacent to the hotel.

Guest rooms at the GADA rate are available on a first-come first-served basis; GADA cannot guarantee availability of rooms, so make your reservation as soon as possible, but no later than **September 29, 2016.** A credit card will be required to guarantee the reservation; the card will be charged for one night’s stay unless the reservation is cancelled more than 24 hours prior to arrival.
